

## MEMORANDUM OF UNDERSTANDING (MOU)

1. *The Faculty of Law, at Luarasi University, Tirana, Albania, represented by the Dean, Prof. Asoc. Dr. Admir Belishta (hereinafter referred to as "Luarasi"), and*
2. *The Faculty of Law at Sinergija University Bijeljina, represented by the Dean, prof. Asoc. Dr. Goran Filipić (hereinafter referred to as "Sinergija University"),*

*Collectively referred to as the "Parties."*

### Preamble

Luarasi and Sinergija University are dedicated to fostering global education, research, and professional practice. Both institutions seek to mutually benefit from shared knowledge, experiences, and resources.

### Article I: Purpose and Objectives

This Memorandum of Understanding (MoU) aims to establish a formal relationship between the two parties to:

1. Promote academic and professional exchanges.
2. Encourage mutual collaboration in research and publications.
3. Facilitate joint conferences, workshops, and seminars.
4. Support the development of academic and administrative capacities.

### Article II: Scope of Collaboration

1. Open Speeches or Discussion Sessions by Professors
  - Professors will engage in open speeches or discussions, contributing to intellectual enrichment.
  - Details to be mutually decided.
2. Round Table Meetings and Case Discussions
  - Collaborative case studies, round-tables, and interactive discussions to facilitate experiential learning.
  - Both physical and virtual platforms can be utilized.
  - Details to be mutually decided.
3. Visits by Students and Academic Staff
  - Cross-institutional visits will extend to students, faculty, researchers, and administrative staff.
  - The visits could include but not be limited to educational tours, specialized training, or short courses.
  - Details to be mutually decided.
4. Joint Research Initiatives
  - The parties may engage in collaborative research projects and grant proposals, including Erasmus+.
5. Publications and Academic Material
  - Co-authoring academic papers, case studies, and reports.
  - Sharing of academic material and resources for mutual benefit.

### Article III: Terms and Conditions

#### 1. Duration

- The MoU remains in effect indefinitely, subject to termination by either party.

#### 2. Confidentiality

- Both parties shall respect the confidentiality of any proprietary or confidential information shared.

#### 3. Legal Framework

- This MoU is subject to the laws of the jurisdictions where each party is established.

#### 4. Termination

- Unilateral termination with written notice is acceptable:

- Modifications must be made in writing and signed by both parties.


#### 6. Dispute Resolution


- In the event of a dispute, both parties agree to engage in good faith negotiations to resolve the issue amicably.
